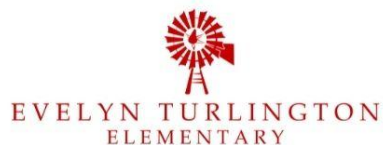
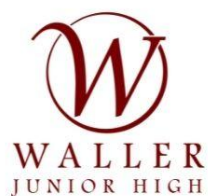
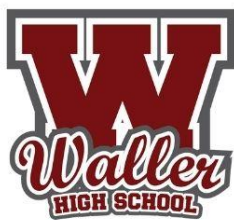

# STUDENT/STAFF HEALTH & SAFETY

## General

As prior to the COVID-19 pandemic all students, including children with disabilities, and staff are expected to self-screen for any communicable illness before coming to work or school. If a communicable illness is suspected, please consider being assessed by a medical professional before returning.

State rules require schools to exclude students with certain illnesses from school for certain periods of time. For example, if a child has a fever over 100.0 F, he or she must stay out of school until fever-free for 24 hours without use of fever-reducing medications. Students with diarrheal illnesses must stay home until they are diarrhea-free without use of diarrhea suppressing medications for 24 hours. A full list of conditions for which the school must exclude children can be obtained from the school nurse. More detailed information on student health procedures may be found in the [WISD Student Handbook](#) under the Absences/Attendance and Illnesses sections. Any illness-related absence should be reported to [the campus nurse](#).

## COVID-19 Screening

All students, including children with disabilities, and staff are expected to self-screen for COVID-19 before coming to school or work each day. Symptoms include, but are not limited to:

- Feeling feverish or a temperature equal to or greater than 100.0 F
- Loss of taste or smell
- Cough
- Difficulty breathing
- Shortness of breath
- Fatigue
- Headache
- Chills
- Sore throat
- Congestion or runny nose
- Shaking or exaggerated shivering
- Significant muscle pain or ache
- Diarrhea
- Nausea or vomiting

If COVID-19 is suspected, please see a medical professional and report the illness to the [school nurse](#). Procedures will be followed per the [WISD Student Handbook](#) and this document.

## COVID-19 Testing

Individuals who feel they need to be tested for COVID-19 should contact their medical provider or seek a local clinic for services. Most COVID-19 testing is conducted at no cost to the patient. ## COVID-19 Vaccinations

Everyone age 12+ is eligible to receive a COVID-19 vaccine at no cost. The vaccine is not required for WISD students or staff, however it is strongly encouraged for eligible individuals. The CDC has proven that the vaccine is safe and effective in preventing or drastically diminishing the effects of COVID-19. WISD occasionally works in collaboration with local providers to host in-district vaccination clinics. In-district vaccination clinics will be posted on [wallerisd.net](#) and [official WISD social media](#). ## Illness Isolation

Any student or staff member who becomes ill or is suspected of being ill during the school day will report to the school nurse for evaluation. Each school nurse will have designated “sick” and “well” visit areas within the clinic. Illness procedures will be followed according to the WISD Student Handbook. If an individual tests positive for COVID-19 school nurses will work in partnership with families and medical professionals to determine necessary contact tracing, quarantine days, and return to school date.

## Face Masks, PPE, & Social Distancing

Per [Executive Order GA-38](#) by the governor of the state of Texas, school systems cannot require students or staff to wear a mask. **While masks are not required, they are strongly encouraged to help protect the health of individuals and those around them.** As part of good practice, individuals will be asked to maintain social distancing to the extent possible.

## Arrival & Dismissal

- No loitering is allowed outside school buildings; please do not drop off students early.
- Designated entry/exit doors will be propped open for sanitary reasons. Any open doors will be monitored by staff to stop unauthorized access and monitor for threats.
- Separate entrances/exits will be used for different groups of students (i.e. bus riders, car riders, etc.).
- Hand sanitizer will be available and encouraged at all entrances/exits.

## Hand Washing/Sanitizing Expectations

Frequent hand washing/sanitizing will help ensure the health and wellness of the WISD family.

- Hand sanitizer will be available in all entries, classrooms, cafeteria, common areas, and throughout the building.
- Individuals will be expected to regularly wash or sanitize their hands.
- Students will be reminded to wash or sanitize their hands during appropriate times of the school day.
- Thorough hand washing or sanitizing is required before and after eating and following restroom breaks.
- Signs will be posted in all restrooms and hand washing areas to remind individuals of good hygiene practices.

## Meals

- Lunch times will be staggered with sanitation blocks in between.
- Cafeteria capacity will be based on current guidelines from state and local officials.
- Microwaves will not be available for sanitary reasons.
- To assist families in recovering from the COVID-19 pandemic, meals for all students will be free during the 2021-2022 school year. Please note that although meals will be free, if you are new to WISD or have had a change in income and may qualify for [Free or Reduced Meals and do not currently have an application on file, please complete an application online](#). ## Drinking Water

For sanitary reasons, WISD recommends that all students and staff bring a large water bottle with a flip or screw-top lid to school/work each day. Bottle fillers will be turned on where available. Water fountains will be turned on for use as needed, however personal water bottles are preferred.

## Activities & Events

---

- Field trips may be taken in compliance with the state and local guidelines.
  - Teachers and chaperones will encourage hand washing or provide hand sanitizer as appropriate.
- Students may participate in work-based learning in compliance with state and local guidelines.
- PTO events and fundraising will be allowed in compliance with health and safety information provided in this document.
- After-school clubs may be held in compliance with health and safety information provided in this document.
- Visitor attendance at school programs, class parties, meals, etc. is permitted in compliance with [Visitor Health & Safety](#).

- Practices and contests will be conducted following health and safety information provided in this document and in compliance with applicable UIL and TEA rules.
- Spectator/visitor attendance is permitted in compliance with [Visitor Health & Safety](#).

## STUDENT ACADEMIC PROGRESS & MENTAL HEALTH

The comprehensive needs of all students, including children with disabilities, is priority for WISD. This includes their physical health and wellness, mental health and wellness, and academic progress. All students have been affected by the COVID-19 pandemic and will require special attention to needs moving forward.

- WISD regularly reviews individual student data to determine needs for accelerated instruction plans for students.
- WISD will utilize intervention time, which is built into every school day on all campuses, as well as before and after school labs to assist students.
- WISD offers all students professional counseling services on all campuses.
- WISD offers all students and families the services of its Community Youth Specialist, a professional social worker.
- WISD's Family Engagement Specialist works to partner with parents/guardians and other family members to assist in serving the needs of the whole child.

# CLEANING & SANITIZING PROCEDURES

Frequent cleaning and sanitizing promotes a healthy learning and work environment for students and staff. WISD provides frequent cleaning and sanitizing services for all facilities using antibacterial and antiviral products and medical-grade disinfectant.

## Facilities & Equipment

- All used areas of facilities including classrooms, restrooms, offices, and common areas will be cleaned and sanitized daily.
- All high-touch areas will be sanitized as needed throughout the day and each evening.
- Custodial staff will wear gloves.
- Breakfast and lunch areas will be sanitized between each meal.
- Staff and students will have access to cleaning products to sanitize working surfaces and shared objects between use and as needed throughout the day.
- Teachers/coaches will develop, teach, and implement procedures that:
  - Establish student responsibilities to clean personal areas and materials/supplies/equipment with appropriate cleaning products.
  - Relate to entering and exiting the classroom. Ex. “Clean when you enter, clean before you leave.”
- In the event of a confirmed case of communicable illness including COVID-19, additional deep cleaning and sanitizing in areas visited by that individual will be completed as soon as possible.

## Transportation

- When possible, buses will open windows to allow air to circulate.
- Drivers and riders will be encouraged to use provided hand sanitizer upon boarding a bus.
- Buses will be cleaned and sanitized daily.



# VISITOR HEALTH & SAFETY

## General

Visitors will be allowed at all schools and offices during regular work/school days by appointment only. No visitors will be allowed during meal times. All visitors are expected to self-screen for any communicable illness before coming to a WISD facility. If a communicable illness is suspected, please reschedule your visit. Virtual meetings may be available for certain meetings such as parent/teacher conferences, ARDs, etc. If a virtual meeting is desired, please inquire with your child's teacher or campus administrator.

- Signs will be placed on entry doors to remind visitors to self-screen for illness before entering the building.
- Hand sanitizer will be available at all visitor entrances.
- Please maintain social distancing to the extent possible.

## Ticketed Events

WISD's E-Ticketing system will be used for any event that requires a fee for entry including, but not limited to athletics, fine arts, etc. [Tickets must be purchased online.](#)

## Free Events

Any free event at the elementary, junior high, or high school level will not require tickets. Guests will be allowed to enter on a first come, first-served basis while seats are available.
